The pond fountain has been reinstalled in the pond for the season. The treatment of the pond will begin as soon as the water temperature warms up to do so. We are also looking into installing additional fountains in the pond depending on the availability of electric and cost.

Harmony Tree company was hired to remove trees recently on Birch & Ash lanes. We have requested a proposal to stump grind the stumps from this past fall and the new ones along with soil & seeding these areas this spring.

Loeffler Pool has been hired to re-finish the inside of the pool and to perform other repairs around the pool deck surface. They have started to drain the pool and will start the repairs and resurfacing the inside of the pool ASAP so the pool will be ready for the pool season. Nothing new has changed with the operation of the pool so far as state regulations but we are monitoring any changes and will report these prior to the opening of the pool memorial weekend.
