# **Community Maintenance Activities**

Gay McHugh continues to visit the site on Wednesday's between 2PM-5PM. He has been walking the site and meeting with owners to address concerns and follow up on work orders.

The Country Nursery continues their weekly landscape maintenance at Harding Green. Over the past few weeks this vendor has completed the mulching of the property and the pruning of the shrubs. They will be addressing the special request pruning the week of July 31st.

American Pool has done a very good job so far this year operating the Harding Green pool. They supply weekly reports and have been responsive to all requests.

Many Harding Green owners have been experiencing overflowing gutters during that last several storms. Express Painting who cleaned the gutters this spring has received all work orders and will be rechecking and cleaning these problem gutters.

Express Painting has been a little behind schedule with the re-siding/painting on Ash and Beech. They will be back on schedule late July and continue to work toward completion in mid-August.

NJ Pest Control will resume the bat exclusion/bat proofing project on August 1st. This is the earliest they can start because of Federal law. They will be setting up one-way valves to exclude the bats in the areas where they are active. They will then continue sealing all openings where bats may penetrate and re-screen all roof soffits using perforated aluminum sheets.

Gary has been working with the board soliciting bids for driveway replacements/repairs and seal coating. The board will review the bids and select the vendor.

The meeting was called to order at 7:47.

- 1. Approval of the minutes from the last meeting 4/0.
- 2. Treasurer's report:
  - a. As of May 31, 2017: operating account: \$153,197.86; capital reserve account (with FISN): money market account: \$106,461.87; several CDs (average yield about 2.8%): \$618,000.00;
  - Approval of transfer of funds from reserve to operating to pay for the following projects:
    \$7,140.00 down-payment to All American Chimney Services to replace 21 chimney covers and caps;
    \$6,078.74 payment to Express Painting Contractors for the re-siding project on Ash and Beech.
    Approved 4/0.
- 3. Introduction of Gary McHugh our new property manager
- 4. Project updates / discussion:
  - a. Waiting for building permit to complete phase two of the bathroom project
  - b. The board is looking to fix items to last long term as opposed to patching problems for a quick fix
  - c. Tree work and stump grinding will continue
  - d. Grass needed areas
  - e. Bat-proofing project: active bat colonies by federal law cannot be touched until August, the work will resume after August 1.
  - f. Discussion on how to eliminate water issues in common areas
  - g. Cleaning of down spouts: Express Painting Contractors will be requested to address areas where downspouts are clogged.
  - h. Looking at present and new vendors for pricing and quality of work
  - i. Better supervision of workers making sure the jobs are done correctly
  - j. It was mentioned that the flower pots at the pool need to have enough water each day
  - k. Discussion of watering the entry of Harding Green Drive
  - 1. Tennis Courts need to be looked at for repairs
  - m. Question from a new resident regarding trimming bushes. The resident was happy to hear that it will be done and they do not have to do it.
